Regular Board meeting of the Village of Chaumont Board of Trustees

Deputy Mayor Nichols opened the Village of Chaumont Board of Trustees February 18, 2020 Regular Board Meeting at 6:30 p.m. with the Pledge of Allegiance. Deputy Mayor Nichols requested that the minutes reflect that Mayor Rust is absent this evening.

Privilege of the Floor

No one was present for privilege of the floor.

DPW Updates

Deputy Mayor Nichols asked John about the snow blower currently used at the transfer site as a shared service. The blower is no longer needed by the transfer site. John replied that the snow blower is only worth the money as scrap metal as it is very old. John recommended that we give it to the Town for them to dispose of as they see fit. John also reviewed the list of equipment that is being insured by the Village's insurance. He commented that the Massey Ferguson mower is not working and should be removed from the list. He said that the Simplicity mover is the newest mower and should be insured with a value of \$1,500.00-\$2,000.

UV lights have been ordered for the WWTP at a cost of approximately \$1,000.00.

John reported that the beach is a mess as ice fishermen have been parking on the lawn due to overflow of the lot and then gaining access to the ice in numerous places. All of this activity has caused ruts on the lawn and has destroyed the beach area. He has placed "No Parking" signs however the signs are being ignored. Cleanup this spring will be extensive. There was a short discussion of how to keep individuals from parking on the grass. John suggested that if an agreement could be reached with a private property owner on Wilson Lane, overflow parking could eliminate parking on the grass and a designated area could be used by them to get onto the ice.

Chaumont Vol. Fire Dept Roster

An updated member roster received on Jan 25, 2020 was reviewed by the trustees. Upon a motion by Trustee Froelich, seconded by Trustee Reome and unanimously passed, it was resolved to accept the member roster as submitted.

Village Planning Board Public Hearings
