## **New Business**

Deputy Mayor Nichols asked whether we have considered asking residents to run water due to the extreme cold. Karen stated that Greg said that there is not a fear of waterlines freezing right now since the ground has not frozen yet and the snow will insulate the municipal lines.

#### **Old Business**

Our new 2019 Ford F-350 Dump/Plow truck arrived today. The amount paid was \$56,355.00. Transfer of funds from GF Savings in the Amount of \$20,000.00 and \$36,000.00 from Water Fund Savings to General Fund checking to pay for the truck at this time. Reimbursement to these funds will be from CHIPS funds balance of \$38,341.41 and Extreme Winter Recovery fund balance of \$7,820.64. The difference between purchase price and CHIPS funding is \$9,837.95. The DPW has scheduled to sell the 2008 Dump truck via Auctions International with an estimated sale price between \$3,000.00 and \$6,000.00. Proceeds from the sale will also be used towards the purchase of the new truck.
